11:07/25 COUNCIL VACANCIES

11:07/27 STOWFORD LODGE

11:07/28 STREET LIGHTING IN DEVON

Devon County Council had approved a policy of part-night lighting in residential areas across the whole of the County. They reported that this was being implemented to reduce carbon emissions and energy costs. The County Council had supplied plans showing all the lights within the Town Council's area and identified lighting points which were designated A and B roads and would therefore remain lit all night. At the July Town Council meeting it was resolved that Members would review their wards and report back to this meeting.

The Chairman reported that after implementation of this policy there would be future reviews when minor changes could be proposed.

RESOLVED: That this be noted.

11:07/29 SIDMOUTH TOWN COUNCIL TIES, SCARVES AND PINS

The Chairman showed Members suggested designs for the Town Council ties, scarves and badges.
